

## Inmate Bar Code Movement


Inmate Bar Code Movement will display the scanned inmate for verification, if desired. The module will track both interim “check-point” movements and final destination movement

locations. When a destination is defined it will appear on the primary bookings screen for institutional review until the inmate arrives. Once the inmate arrives at the final destination the field disappears indicating that the current location is the inmate’s current destination.
